Around 52 participants consisting of students, residents of Okamb village and staff members of GMFC attended this event. The function was graced by the presence of eminent dignitaries Smt. Sunita Gaunekar, Civil Judge Junior Division, and Judicial Magistrate First Class, Sanguem, Goa; Shri Ajay Gaude, Dy. Collector, Revenue, North Goa and Shri Mangaldas Gaonkar, Asst. Commissioner Excise, Panaji.

Adv. Abhilasha Naik and Adv. Ishwar Kuttikar served as the main resource persons for the event.

The objective of the programme was to create awareness about various free services provided by the Legal Aid Cell (such as advice on Legal matters, free legal representation by qualified advocates in both civil, criminal and revenue courts etc.) and to enlighten participants on how to access services of the Legal Aid Cell.

The Principal, Prof. (Dr.) Shaikh Mohammad Parvez Al-Usmani, welcomed the gathering and stated his intention to develop the college to act as an essential

She also explained certain pre-litigation procedures, Lok adalats etc.

Adv. Ishwar Kuttikar focused on the importance of the United Nations Day observed on 24th October. He discussed various types of free aid services which are available for civil cases such as land disputes and explained in detail the procedure

required for availing benefits of free aid. He further touched upon the few sections of Motor Vehicle Act.

Finally, a Question & Answer session was held wherein the participants were given the opportunity to voice their queries regarding multiple legal issues encountered at a personal and community level.

The event concluded with a Vote of Thanks proposed by Asst Prof. Kalpita Naik. The Programme received overwhelming response from the participants.
